Expert Qualifications:

A copy of my current resume is attached as an (Exhibit #1). In brief, I have fifty three years of combined experience in the fields of the military, law enforcement, martial arts and private investigations. I am a retired Huntington, WV Police Officer where I served as a Major Crimes Detective working homicides, kidnappings, rapes, burglaries, fraud and felonious assaults. I also worked extensively on patrol, drug task force, tactical unit, SWAT unit, and Huntington Police Recruit Training Academy Police Defensive Tactics instructor. I have thirty-seven years as a licensed private investigator in West Virginia & Kentucky working thousands of criminal, civil and domestic cases nationwide. I have been certified and testified as an expert in several areas of investigations which is on my CV. I have fifty three years of training in the Marine Corps, Police, and martial arts. I am a Master in the Chuck Norris System and have trained with Chuck Norris for 40 years. I hold Master ranks in numerous other styles. I have taught numerous local, state and federal agencies nationally and internationally numerous times over my career. I was invited to teach the Secret Service Presidential Guards at the Service Training Academy in 1992 when President Bush Sr, was President. I taught them how to end a threat in less than a second or two. "If it takes time to think then it's too late". Self-defense in real life and death situations are done instinctively and without thinking. That is accomplished by repetitive training, metal preparation and confidence in the techniques. I was invited to teach at the New York Tactical Association & SWAT convention in Syracuse NY several years ago. Attending were New York Officers, SWAT teams, US. Customs Officers, Border Patrol and other federal agencies across the country. I have taught police officers internationally in Puerto Rico, Spain, England, Mexico, and the Canary Islands.

Background of Case:

On 10/11, 2020 A Protective Order 0M-00322-20 was issued by a Judge in the Town Of Woodbury taken out by **Ana Maria Montano Gupta** against **Jayquan M. Lightfoot**. The Order said that Mr. Lightfoot had to stay 1000 feet away from Ms. Gupta. The Order was in effect until November 11, 2020. The charge Ana Maria Montano Gupta files against Shaquan M. Lightfoot was for **Grand Larceny x4**.

On 11/05/20 @ approx. 0225 hrs. a male identified as **Shaqaun Lightfoot**, Jayquan M. Lightfoot's brother, showed up at the Emergency Dept. at Garnet Health Medical Center at 707 E Main St, Middletown, NY 10940. He was demanding to visit his spouse who was under hospital care in ED Rm. 21.

Below is the Hospital Incident Report.

On 11/05/20 @ approx. 0225 hrs. a male identified as Shaqaun Lightfoot approached the undersigned at the Emergency Dept. waiting room entrance **demanding** to visit his spouse who was under hospital care in ED Rm.21.

The male was **obviously intoxicated** with **slurred speech and unstable gait**. When the male was informed he was not able to visit the patient he became **verbally abusive and threatened to assault the undersigned** and **anyone who would try to stop him** from entering.

After **further threats and verbal abuse the male he left the location** and entered a dark colored SUV near the Emergency Dept. waiting room entrance. That SUV was occupied by a male operator, **Jayquan M. Lightfoot** and female passenger. The SUV was observed exiting towards Parking lot C alongside the POB in an **unsafe manner at a high rate of speed**.

The vehicle reached the outer roadway and turned left. A canvas of the parking lot cameras was conducted with negative results. Charge Officer Baez dispatched an available unit to check the ground floor entrances with negative results. No further action was taken.

Investigator Note #1: This is when the party of three showed their **FIRST** display of respect for the compliance of rules and policies with hospital security guard, John Politoski.

(statement continued)

At approximately **0237** hrs. Shaqaun Lightfoot returned to the Emergency Dept. waiting room area **again with Jayquan and the female passenger in the SUV. He attempted to enter** the location again. He became **verbally abusive and threatening again.**

A female later identified as **Anna Marie Montano~Guptha** stepped in front of him and pushed him away towards the parking lot.

Wallkill PO was requested.

Investigator Note #2: This is the **SECOND** display of showing no respect or compliance of hospital rules and policies.

(statement continued)

The two entered the SUV operated by a male later identified as Jayquan Lightfoot.

They again drove away in an **unsafe manner at a high rate of speed.**

Investigator Note #3: This is the **THIRD** display of noncompliance of rules and safety.

(statement continued)

As they exited the ED area towards Parking lot C they encountered a responding Wallkill PO unit.

The vehicle attempted to park unobserved with occupants exiting the vehicle and walking away.

As a Wallkill PO solo unit approached the suspect vehicle the undersigned **heard yelling and observed the occupants not complying with the officers orders to STOP.**

Investigator Note #4: This is the **FOURTH** display of no respect and compliance for the law when **Jayquan Lighfoot** refused to comply with orders from the responding officer to STOP!

As further Wallkill PO units were arriving on scene, the operator **Jayquan Lightfoot physically resisted** Wallkill PO **Officer Officer Daniel Traum-Steinberg**, **resulting in his arrest**.

Investigator Note #5: This is the FI**FTH** display of no respect or compliance of the Police Officers and the law.

After he was placed in handcuffs the suspect **coughed directly into PO Officer Officer Daniel Traum**-Steinberg's face numerous times stated that he had COVID 19. He continued to do the same causing the officer to bring the suspect to the ground.

Investigator Note #6: This is the **SIXTH** display of noncompliance of the Police and the law and presented an imminent threat to the Officer with a deadly biological disease.

As suspect Jayquan Lightfoot was brought to the ground **Anna Marie Montano~Guptha was filming the** incident and screaming "I got you" "I got you MF" several times and moved closer to the Officer and some point not on the video pushed at him. You notice that she zoomed in on the Officer's Badge and face. She then started saying that he had seizures.

PO Officer Officer Daniel Traum-Steinberg immediately called headquarters and summoned the hospital security guard to call for medical assistance. Officer Braun-Stein placed him on his side to maintain his airway and protect his head.

A medical response was requested by the undersigned from the ED staff. As per responding ED staff he was transported to ED Room 37 from Parking lot C via Wallkill PO RMP.

Upon arrival in EO he responded quickly to treatment and was conscious and alert.

During suspect Jayquan Lightfoot's arrest and seizures the **female Montano~Guptha attempted to** interfere and began to resist officers attempt to restrain her.

A struggle ensued causing her arrest and injuries to Officer Lindeman Wallkill PD.

Officer Lindeman was treated and released for wrist and knee injuries in ED Room 17.

Investigator Note: This is the **SEVENTH** display of noncompliance. It took several Officers to get her to the ground as she was fighting. She is a large woman and was very aggressive.

The undersigned assisted Wallkill PO with both suspects for officer safety and defendant's medical emergency.

No charges pending for the initiator of the incident Shaquan Lightfoot as per **Wallkill PO Sergeant** Loucks.

No injuries to Security or ED staff.

Willkill Police Officer Ganese Bhagwandeen arrives on scene.

On 11/05/2020 at approximately 0237hrs, Member were dispatched to Garnet Health for **subjects intoxicated causing a disturbance** at the Emergency room entrance.

Member arrived on scene where a black 2017 Dodge Journey bearing NY REG EGY-96S6 was leaving the area of the front ER entrance.

Upon pulling up to the front member was advised by hospital security that that was them leaving in the vehicle.

Member followed vehicle where one male later known as **Jayquan W Lightfoot** got out of the vehicle in the Parking lot C of Garnet Health and then the vehicle began to drive off.

Member followed said vehicle where it later parked in parking lot C further down.

Member called for additionally units and read the plate off the vehicle when the driver of the vehicle later to be identified as AR Jayquan M Lightfoot got out of the vehicle and attempted to flee on foot.

Investigator Note #7: This is the EIGHT display of noncompliance of the Police and the law.

(statement continued)

While member was attempting to stop AR Lightfoot, PI **Lightfoot started to run towards member** at the same time as AR Lightfoot was approaching member.

Investigator Note #8: This is the NINETH display of noncompliance This **aggressive behavior running towards the Officer shows total disregard of fear of the law**.

(statement continued)

PO T. Steinberg arrived on scene and AR Lightfoot started to flee again, so member told PO Steinberg to get AR Lightfoot.

PO Steinberg ran and detained AR Lightfoot and after a struggle and resisting arrest he brought him back to where member was.

Investigator Note #9: This is the TENTH display of noncompliance This aggressive show of fleeing shows total disregard of the law and that he is guilty of something or doesn't want to go to jail for anything.

Note: Officer Steinberg stated he had to run to catch up with Lightfoot. Lightfoot saw he was going to smoke and did not comply with the Officer's order. Lightfoot was put in handcuffs and resisted the Officer during the detainment.

(statement continued)

Member did not see the next occurring events but when member turned around AR Lightfoot was on the floor and appeared to be having a seizure.

Hospital staff arrived on scene to provide aid for AR Lightfoot when member placed two nurses and AR Lightfoot in the back of patrol vehicle #74 to be rushed to the emergency room.

Member stayed with AR Lightfoot and issued AR and appearance ticket to appear in the Town Of Wallkill Court. November 25, 2020 at 0900 Hrs to stand before the Honorable Judge Joseph Owen.

Lightfoot's right arm and placed it behind his back and in cuffs.

Member instructed AR Lightfoot to give Member his left arm which **AR refused** stating **that he was going to smoke.**

Member took AR Lighfoot's left arm and placed him into cuffs.

AR **Lightfoot attempted to prevent Member from doing so** by tensing up and Member had to force the arm.

Investigator Note #10: This is the **ELEVENTH** incident of failure to comply with law enforcement and hospital security.

(statement continued)

Member then walked AR Lightfoot over to Car 74 and had him sit on the rear bumper while AR Lightfoot he was being detained for investigation.

Upon reaching car 74, AR Lightfoot stated "No mask. I've got COVID bro" and started coughing in Member's direction at a distance of less than 10 inches from Member's face.

Member turned AR Lightfoot around facing the car and instructed him to stop coughing.

AR Lightfoot attempted to pull away from Member but was prevented from doing so.

Investigator Note #11: This is the TWELVETH incident of his failure to comply with law enforcement. **Where is the video of this incident?**

(statement continued)

AR Lightfoot stated repeatedly "No mask. COVID and 6 feet" with no coherent order to them.

Member informed AR Lightfoot that if he coughed on Member again he would be placed on the ground.

Investigator Note #12: This is the THIRTHEENTH incident of his failure to comply with law enforcement and threaten him with a deadly disease.

(statement continued)

AR Lightfoot told Member to remove his hand from AR's right arm and Member informed him that he would not because of AR's repeated attempts to leave the scene.

AR Lightfoot repeated the above statements before asking if he could then sit down.

Investigator Note #13: This is the **FOURTEENTH attempt of noncompliance.** There was no reason for Lighfoot to sit down at that point. Based on my experience the "sit down" request is used by suspects all the time to escape. Lightfoot requested that the Officer remove his hold on him so he could sit down but it could have been a plan to flee again.

(statement continued)

Member told him he could do so.

AR Lightfoot started to do so then **coughed once facing forward then turned and coughed in Member's face** from a distance from less than 10 inches.

Investigator Note #14: This is the **FIFETTENTH attempt of noncompliance.** Lightfoot coughing obviously was an intentional act to make the Officer think he had Covid and it would infect him. This use of having Covid is also used by criminal suspects nationwide to avoid arrest or to escape.

(statement continued)

At this point Member took AR to the ground.

As Member detained AR Lightfoot who **was yelling inarticulately**, AR **Montanogupta** came running up screaming at Member insults and that AR Lightfoot has a medical condition.

Member told AR Montanogupta to "Get back" which AR ignored.

Investigator Note #15: This is the **SIXTEENTH attempt of noncompliance.** Another refusal to comply and obey orders by the Officers.

At this point Member felt AR Lightfoot begin to shake and observed AR to appear to be having a seizure.

Member rolled AR Lightfoot onto his side and stabilized AR's head to prevent injury.

At this point AR Montanogupta came **up yelling at Member and placed her hands on Member** attempting to push Member away from AR Lightfoot.

Member pushed AR Montogupta away from Member as AR continued to yell.

Investigator Note #16: This is the **SEVENTEENTH attempt of noncompliance. Pushing the police and interfering is against the law.**

(statement continued)

At this point PO Lindeman arrived on scene and made contact with AR Montanogupta.

Shortly afterwards Member observed AR Montanogupta shove PO Lindeman and subsequently physically resist PO Lindeman and PO Ponds when they attempted to place her into custody.

Investigator Note #17: Montogupta got arrested and was taken into custody for pushing the police and interfering.

Member requested Garnet Health Security Officer John who had arrived on scene to contact medical assistance and he did so.

Member stayed with AR Lightfoot stabilizing him until medical staff arrived on scene.

Member then assisted PO Lindeman and PO Ponds in placing AR Montanogupta into Car 73.

AR Lightfoot was placed into Car 74 and transported to the ER under the custody of PO **Bhagwandeen**. PO Bhagwandeen remained at Garnet with AR Lightfoot.

Member advised SGT Loucks of the situation and possible COVID exposure, and remained at Garnet Health as per Sergeant's instructions.

As Member waited OW Rotundo made contact with Member and stated that to the best of her knowledge AR Lightfoot did not have COVID. (How?)

After an investigation into the possible exposure it was determined to be unlikely that AR Lightfoot had COVID and Member returned to TWPD Station.

Member assisted PO Ponds with processing AR Montanogupta (see PO Lindeman supplemental narrative regarding charges for Montanogupta).

Member spoke with AQA Lori Goldberg in regards to charges for AR Lightfoot.

SGT Loucks contacted NYS COVID Hotline who advised that Member needed to be tested for COVIO due to AR Lightfoot's claim.

Member scheduled COVID test with Middletown Medical on 11/9/20.

Willkill Police Officer Madison Lindeman's report.

On above listed date and time members of TWPD were dispatched to a disturbance at Garnet Medical Center.

Units were advised prior to arrival that three subjects were attempting to gain access to the ER to visit a friend. Dispatch also advised that the subjects were possibly leaving in a vehicle.

PO Bhagwandeen arrived on scene first and observed said vehicle and began to interview occupants in the parking lot.

PO Traum-Steinberg arrived shortly after and began attempting to interview one of the occupants (see supplemental narrative).

This member arrived shortly after PO Traum-Steinberg detained subject later identified as Jayquan M Lightfoot. PO Traum-Steinberg knew that Jayquan Lightfoot had a Protective Order against him taken out by Montogupta. They both were in violation of her own order. PO Traum-Steinberg put Lightfoot in handcuffs because he was in violation of the Protective Order.

At this time the female subject, Jayquan's Girlfriend, later identified as Anamaria Montanogupta approached PO Traum-Steinberg and shoved her.

Investigator Note #18: Montogupta pushed PO Traum-Steinberg.

(statement continued)

Member observed this and approached Montanogupta attempting to interview her and calm her down,

Montanogupta refused to answer any questions and kept attempting to get back towards PO Traum-Steinberg and Jayquan.

Member gave **multiple verbal commands** for Montanogupta to step back.

She refused multiple orders, and then using two hands shoved member in the chest.

Member at this point attempted to place Montanogupta into custody for harassment and obstructing government administration.

Investigator Note #19: Montogupta attacked PO Lindeman.

(statement continued)

Montanogupta **refused orders** to put hands behind her back and physically ripped arms from member. Subject then **continued to push, and strike member, as well as attempted to break away from member.**

PO Ponds arrived and assisted member in taking subject to the ground to gain custody.

Montanogupta further resisted locking her arms across her chest refusing to place hands behind her back.

Eventually member and PO Ponds were able to secure subjects hands and place into rear cuffs.

Member then attempted to escort subject to patrol vehicle 73.

Montanogupta purposely locked her legs refusing to walk and intentionally collapsed to the ground.

Members placed subject into the rear of patrol vehicle 73 when subject kicked member in the stomach.

PO Ponds transported female subject back to TWPD for processing.

Member then realized that there was a small laceration on right wrist and pain and swelling followed. Member was evaluated by Garnet Health staff and determined to have a bone contusion, and sprain of the right wrist.

Member also suffered minor lacerations on both knees. Member was treated and released by Garnet Medical Center.

Montanogupta was processed and charged with two counts of harassment, assault third, attempted assault second on a police officer, OGA and resisting arrest.

Investigator Note #20: There were more than 20 times of noncompliance, trying to flee, assault, resisting arrest, threatening hospital security and a threats of attacks by both Lightfoot and Montanogupta .

PO Officer Officer Daniel Traum-Steinberg was attacked with what Lighfoot said was Covid which is a deadly disease.

Officer **Madison Lindeman** was **injured** and had to be treated at the hospital for injuries inflicted on him by Montanogupta.


Investigator Note #21: Montanogupta was violated her own judge's order when she was with Lightfoot when she had a protective order against him for Grand Larceny x4.

PO Officer Officer Daniel Traum-Steinberg didn't know if he infected with Covid 19 or not until he could get tested. He had to quarantine for 4 days from his family and work.

Jayquan Lightfoot was treated and released several hours later from the hospital. Hospital records indicate....


Background of Suspect Jayquan M. Lightfoot:




His DOB is 11/14/1996. He is 5'7 and weighs 160 pounds according to the police report. A TLO background report lists his current address as **26 OGDEN ST APT 2, MIDDLETOWN NY 10940-4010 (ORANGE COUNTY)** (12/30/2020 to 02/08/2021) His Facebook Profile Page states he lives in New York, New York. His profile states he grew up Yonkers, NY. He is now married to the codefendant since February 6, 2021.


The profile picture was posted on Facebook as his new profile page on November 14, 2020. This was **nine days after the incident.** It was his birthday and he posted this picture along with the picture to the right and below of cash which is consistent with drug money. There are numerous pictures and videos on his profile of him doing drugs and pictures of cash like on the right. This will be disclosed in detail in my Expert Opinion at the end of the report.







Background of ANAMARIA MONTANO. Her date of birth is 1/18/1996. She is 5'1" and weighs 225 pounds. A TLO background report shows her address as **223 INGRASSIA RD**, **MIDDLETOWN, NY 10940-2232 (ORANGE COUNTY)** (06/2015 to 02/15/2021). Ana Marie has a history of criminal behavior in Wallkill. She is accused of attacking a Wallkill Sergeant and punching Jaquan in the face. She and Jaquan was screaming "she is pregnant" during the fight with the Wallkill Officer. This turned out not to be true. Note: PO Traum-Steinberg states there was video of that altercation.





Ana Marie in many of her posts on Facebook refers to dope and getting high.

Investigator opinion of the incident, the suspects and police actions:

After reviewing all of the above statements of the police officers and hospital security guard, it is my opinion that all the officers and hospital security used extreme patience, restraint and limited physical force to resolve the incident.

In brief review, the suspects came to the hospital intoxicated at 2:27 am in the morning and Shaquan Lightfoot tried to get into the hospital against the security guards orders. He was not wearing a mask and hospital policy didn't allow visitors at that time.

The Security Guard describes him as intoxicated, slurred speech and unstable gait. He became **verbally abusive and threatened to assault the undersigned** and **anyone who would try to stop him** from entering.

After **further threats and verbal abuse the male he left the location** and entered a dark colored SUV near the Emergency Dept. waiting room entrance. The SUV was observed exiting towards Parking lot C alongside the POB in an unsafe manner at a **high rate of speed.**

At approximately **0237** hours, the above male returned to the Emergency Dept. waiting room area **attempting to enter** the location again. He became **verbally abusive and threatening again.**

Wallkill PO was requested.

It is obvious from the reports that Shaquan Lightfoot was not going to comply anything that he was told to do. He was noncompliance from the beginning and threating in his actions toward the hospital security.

The driver of the SUV later identified as Jayquan Lightfoot drove at dangerously at a high rate of speed in the parking lot before Wallkill PD arrived.

Jayquan got out of the SUV and fled. He disobeyed orders to stop by the arriving officer. When he was caught he resisted arrest and had to physically restrain to put cuffs on him.

As an expert it is essential to find out all you can about the suspects psychological makeup, frame of mind and intentions.

After reviewing the Facebook Profiles of both suspects, there is clear evidence and admissions of drug use and possibly dealing drugs.

Many of the videos show Jayquan rolling and smoking weed and blunts as he sings rap songs and or does video chats with other unknown men.

In one video the man in the video with him displays a handgun with a laser and flashes it in a proud gesture.

There are several pictures of what I call drug money proudly displayed. Jayquan is seen holding the cash in one picture. In the other he just shows the cash in a box and on the floor.

Ana Marie in many of her posts describes getting high and dope.

As a retired police officer I teach officers to evaluate the psychological makeup of the suspect quickly. It is essential for Officer Safety.

Shaquan Lightfoot was in an animated state when he wasn't allowed to get in the hospital. He left and 10 minutes later came back. Remember the statement of the hospital security guard.

Shaquan became verbally abusive and threatened to assault the undersigned and anyone who would try to stop him from entering.

When Shaquan left they didn't leave the hospital parking lot.

Jayquan tried to flee after being pulled over by police.

In my opinion, Jayquan was going to do anything he could to not get arrested that night.

You also know the motive of Annamarie when she started filming video even before Jayquan was taken done.

When he had to be taken down she interfered with the arrest, screaming, pushing and assaulting other officers.

It took several officers to take her down as she resisted and dropped to the ground to hinder their arrest.

The big question is where is the videos she was taking before the takedown and the events after?

The video presented to us from an edited low resolution Instagram Post and only 30 seconds.

Video breakdown:

Ana Marie filmed the video that showed up on social media in January, 2021 by **Rozay Blaccaveli** on Instagram. He is a friend of Jayquan's.


It was posted by Jayquan on January 11th on his site. His comments are "Willkill Did Dis to me. "I'm Koming for Y'all. What was the Reason.



This **more than two months** after the incident happened. He nor Ana Marie went to the police department all that time to make a Complaint for excessive force until this video surfaced online.

A comment on Jajuan's post of the video by Wallkill Town Supervisor, Frank Den Danto, post shows that no complaint has been made as yet nor an investigation.

He was just made aware of the video went to Jaquan's site and made this comment without any investigation other than looking at the video.




KEY POINTS: Thus far there are no pictures of his face showing injuries sustained that night.


The Chief of Police of Wallkill got a copy of the video on January 15th 2021.


Most times when a person is arrested and claims excessive force they go right away to the police and show the physical and digital evidence and make a complaint.

The conspiracy to go after **Officer Officer Daniel Traum-Steinberg** and Wallkill Police Department started in January, 2021 from Ana Marie and Jayquan. Jayquan has posted twice about the pay.

Examination of the video and use of Force:

I have examined hundreds videos in criminal cases and have been certified as a digital expert in one high profile case in West Virginia. It is in my resume.

- 1. The video was shot by Ana Marie and it obviously was edited to show only part of the incident they wanted. It is only 30 seconds in length. The one presented to me had a @symbol on it and was posted on Instagram. The same video is on Lightfoot's Facebook page but again edited to not hear her screaming and interfering.
- 2. The Willkill Police nor the Distict Attorney in their investigation thus far have not attempted to obtain the true and accurate video of videos that Ana Marie shot that night. It would be of better quality and show all the footage she shot that night.
- 3. The problem examining the video is it had been compressed to post on social media and it loses a lot of quality. Then when it is saved over and over it loses the quality and clarity each time. An IPhone can shoot up to 4K of resolution. The default setting is 1080p.
- 4. I have saved the video in several formats and used my software to enhance the lighting and clarity for an accurate view of the incident as best as possible. I have saved it in slow motion and frame by frame to see if Jayquan's FACE hit the ground as alleged in the criminal complaint and how he landed. In real time the leg sweep is done and over in a little more than 1 second.
- 5. The incident of Jauquan moving back away from Officer Braum-Stein and him using a leg takedown lasted less than 2 seconds.
- 6. Upon watching the video the first time in full speed it is hard to see everything that is happening. It is also hard to verify some of the allegations the District Attorney is alleging in the criminal complaint. I will cover those points in my expert opinion below.

Expert Opinion:

Based on my review of all the documentation and the breakdown of the video at slow motion and frame by frame it is my expert opinion that **Officer Daniel Traum-Steinberg** used the force necessary to stop the immediate, imminent threat of a deadly biological weapon that was used on him by Jayquan Lightfoot.

It is documented that the defendant, Jayquan Lightfoot, said to Officer **Officer Daniel Traum-Steinberg** on several occasions on and off camera that he had "Covid 19 Bro' No mask".

Officer Daniel Traum-Steinberg did not have his mask on because he had to jump out of his vehicle to pursue Jaquan Lightfoot that refused to STOP for the arriving officer.

Officer Daniel Traum-Steinberg had a reason to handcuff Lightfoot since there was a Protective Order in place against Jayquan Lightfoot.

In the thirty seconds of video presented to me to examine, you can clearly see and hear Jayquan Lighfoot COUGH two more times. Once downward and the other directly at **Officer Daniel Traum-Steinberg**.

The video shows Jayquan Lighfoot stepping back away from Officer **Officer Daniel Traum-Steinberg** with both feet just before **Officer Daniel Traum-Steinberg** executed the leg take down.

Prior to that Mr. Lightfoot wanted Officer **Officer Daniel Traum-Steinberg** to let go of his arm. Officer **Officer Daniel Traum-Steinberg** advised him he would not because he had tried to flee before.

Then Jayquan Lightfoot wanted to sit down. Another ploy to get Officer **Officer Daniel Traum-Steinberg**'s hands off of him.

The first 5 seconds of the video is what the entire case is about.

It is not conceivable to me that Ana Marie started the video exactly 2 seconds before the takedown. The part of where she was fighting police is not on there either.

Officer Daniel Traum-Steinberg knew that he was being filmed.

He saw Ana Marie with her cell phone pointed at him well before the take down. He was not trying to hide or get away with anything. He was implementing a lawful arrest in his mind. There was no hesitation in his actions once Lightfoot coughed directly into his face after multiple warnings not to.

The issue is, was the reasonable force justified or was it assault by Officer **Officer Daniel Traum-Steinberg**.

The DA has decided to charge **Officer Daniel Traum-Steinberg** and thus far not pursue the charges on the other two.

The second issue in this case is threatening to infect someone with Covid 19 an imminent threat?

There are currently more than 500,000 thousand deaths contributed to Covid 19 in our country to date.

That is close to all the American Soldiers killed in World War 1, World War 2, Korea and Vietnam.

There are nearly 50,000 deaths and over a million infected in New York alone.

It is well documented in the news media that criminals all over our nation are now using Covid 19 as a way to avoid arrest. It is also documented that many police jurisdictions are arresting these people under the "Terrorist Thread" law.

An example is calling in a fake bomb scare. Even though no bomb didn't go off or was even found, the deadly threat and reasonable fear of being blown up was still suffered by the victim's.

Officer Daniel Traum-Steinberg was taught the "leg takedown" in the Rockland County Police Academy where he trained from February to June 2018. It was taught as a legal technique to use in the case of an imminent threat to get the assailant to the ground immediately with minimal force. He has been on the Wallkill Police Force for $2\frac{1}{2}$ years.

In this case **Officer Daniel Traum-Steinberg** was attacked by a deadly weapon which was the suspect's, Jayquan Lightfoot's mouth.

Jaquan Lightfoot's cough can spread thousands of droplets of his saliva more than 6 feet according to the Covid 19 sites.

When you watch the video in slow motion **Officer Daniel Traum-Steinberg** reacted spontaneously to stop the threat as quick as possible and get him incapacitated. There was no hesitation in his mind set on what measures to do.

He did not continue to strike him or hit him. He immediately called it in to dispatch and asked hospital Security Guard John to get help when he saw Jaquan shaking and his girlfriend Ana Marie screaming he has seizures and pushing at him and shoving the camera into his face. You can see the camera focus in on **Officer Daniel Traum-Steinberg's** face and badge which to me means she has what she wants. She is not filming Jayquan having a seizure at any point on the video.

On the video at 26 seconds in, you can see **Officer Daniel Traum-Steinberg** turn his head to the left and clear his mouth.

In my opinion, he followed all the procedures of the Wallkill Use of Force Procedures 4.1

- a. He used the minimum force necessary to achieve control.
- b. He can use physical force only if it is necessary.
 - 1. to effect an arrest
 - 2. to prevent escape.
 - 3. Defend himself and other from the threat.
- c. If injury sustained he will render medical assistance.

It is yet to be determined by medical experts if Jaquan being taken down to the pavement caused the seizure. He has a history of seizures before.

Willkill Police Department has procedures to handling people that may have Covid 19. If Jayquan



Lighfoot hadn't showed signs of seizure those procedures would have been activated.

In the criminal complaint and the Chief of Police's report there is reference to threw him FACE DOWN into the pavement.

There is no clear evidence of Jayquan's FACE hitting the ground on the video.

There is NOT a frame on the video, any pictures taken at the hospital, no facial injuries mentioned in the hospital records and on his Face Book Posts just 9 days later.

There is no evidence of him being thrown face down on the pavement.

After watching the video more than a hundred times, slowing it down and going frame to frame, below are frame by frame pictures of the take down. I found one frame that indicates how Jayquan Lightfoot hit the pavement. I repeat again that if the District Attorney obtained the true and accurate video from one of the arrestees, Juaquan's wife, we would have better quality. The District Attorney's Investigator, William Moloney, interviewed Jaquan Lighfoot on February 11, 2021. This was three months later, and Jaquan said nothing about being thrown face down on the pavement. He did complaint of a knot of the back of his head but again this is three months later and he's already planned his intention to get paid.

The pictures below show Lightfoot moving back from the Officer and was taken down and landed on the pavement on his left side. In the last picture you can see his right foot sideways, his body on his left side and his arms behind him.

This officer should be **commended not convicted** for his actions that night in my opinion.
